DRAFT MINUTES OF THE MEETING OF THE PLANNING COMMITTEE HELD AT THE CHURCH HOUSE, CHURCH STREET, BODICOTE ON WEDNESDAY, 3 OCTOBER 2018, COMMENCING AT 7.15 PM

- 2. Declarations of Interest

No interests were declared.

- **3. Open session:** No members of the public were present.
- 4. Minutes

The minutes of the meeting held on 22 August 2018 were circulated prior to the meeting. Cllr. Mrs. Washburn proposed that they be accepted and signed by the Chairman, seconded and carried unanimously.

5. 18/00272/TCA – T1 x Lawson Cypress – periodic 25% crown reduction, trim side growth

Virginia House, Church Street

Councillors agreed to raise no objections or comments.

6. 18/01645/F – loft conversion addition of rooflights 11 Town Furlong

Councillors expressed concern at the addition of rooflights on the front of the property. These will be visible from the footway and the conservation area. It was agreed that these could have a detrimental impact on the conservation area setting and the street scene. Councillors agreed unanimously to object.

7. 18/00388/DISC – Discharge of conditions 4 (amended materials plan), 14 (chimney schedule) and 19 (amended parking strategy) of 18/00193/REM Land south of Cotefield Business Park, Phase 2, adjacent to Blossom Field Road

Councillors expressed disappointment with the materials being used for the chimneys. Could we please have materials more in keeping with the properties?

The clerk was asked to confirm with the Planning Department the arrangements for the management of the green open spaces for phase 1 and 2.

8. 18/00792/OUT – reduction in number of dwellings from 52 to 46 Tappers Farm

Councillors agreed unanimously to continue to object to this application based on our previous response. The only difference in this amended application being the minor reduction in number of dwellings.
